This is a critical time for us to take on new projects, including some significant ones from the recent floods, and the key to our ability to rise to the occasion is unrestricted funding: individual donations. We receive about 150 donations each year, from a watershed population of nearly a quarter million people. In order to make our funding goal this year, we are going to need three times as many donations. It's ambitious, but we think it's achievable.

If you value our work, please share your appreciation with a few friends, neighbors, colleagues who might also be interested. If you need some handy 2023 facts, we are:

- Planting over 4,000 trees,
- Restoring fish passage to the Green Mountain National Forest in Fayston,
- Making dozens of home visits through Stream Wise, Storm Smart, and our flood response efforts,
- Installing a stormwater management and filtration system in Barre Town,
- Designing the removal of 5 dams for fish passage, habitat improvement, and flood safety,
- & more!
